### CALL TO ORDER

#### COMMITTEE REPORTS

Clerk Olsen stated that the Personnel Committee did not meet.

Trustee Aviles reported that the CWAEDC was rewarded a grant for \$85,000.00 from USDA for water and sewer projects. The CWAEDC will be hosting a golf outing June 23 at 9:00 a.m. CWAEDC assisted in a grant to pave six foot shoulders on both sides of Red Arrow Highway this summer. Calli Berg resigned as director of CWAEDC. A three member search committee has been established to search for a new director. Supervisor Parrigin announced Coloma Charter Township will honor its remaining 12 month obligation to remain a part of the CWAEDC.

Trustee Duffield stated that the Ordinance Compilation Committee did not meet.

Supervisor Parrigin reported that the Road Committee did not meet.
